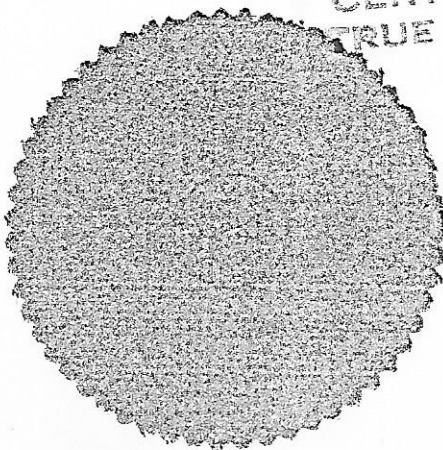

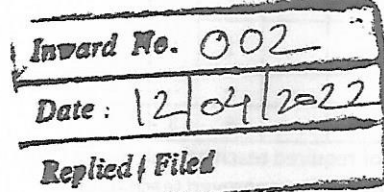

With reference to above cited subject, I am directed to communicate that as per Academic Council Resolution No. 59/2021 dated 28/07/2021 and as per your proposal of Continuation of Affiliation/Extension of Affiliation, the Academic Council unanimously resolved to grant Continuation of Affiliation / Extension of Affiliation for Academic Year 2021-2022 as per the provision u/s 68 and 65 (4) of MUHS Act 1998, for the Homoeopathy (Under Graduate) B.H.M.S. course of your college.

- The intake capacity shall be 60
- Grant of permission from Govt. of India, Ministry of Health & Family Welfare, Department of AYUSH/ National Commission for Homoeopathy/State Government (as applicable).
- Fulfillment of following deficiencies shall be strictly complied within Ninety Days without fail.

You are requested to comply with the above mentioned deficiencies within 3 months (if any) without fail and submit compliance report.

Important Note:

- The Continuation / Extension of Affiliation is issued for the Academic Year 2021-2022 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- The admission shall be done only through the Competent Authorities.

Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

"Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act".

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board

2. WHEREAS, as per the policy of Ministry of AYUSH, CCH examined the Part-1 of the proforma of college submitted by the existing college of Konkan Education & Medical Trust's, Virar Homoeopathic Medical College and has recommended vide letter no. F.No. Virar Homoeopathic Medical College dated 09.12.2021 for not allowing admissions in existing UG Course with 75 seats for the session 2021-22.

4. Whereas, in reference to the representation of college dated 23.12.2021 to Commission, Commission had carefully examined the documents and it was observed that college had not rectified the major deficiencies pointed out by Hearing Committee and MA&RB are as follows:

- i. College failed to submit the affiliation from the MUHS for 2021.22.
- ii. College has still deficiencies of 05 guest faculty against the requirement of 12 for intake capacity of 75 seats.

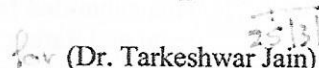
5. WHEREAS, under appeal Commission had carefully examined the documents as per the provisions of the Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic College and attached Hospitals) Regulations, 2013 and the relevant regulations made there under and it was observed that the college has not rectified the major deficiency pointed out by the Hearing Committee and MA&BH vide letter No. 4-7/2021-22/NCH (MA&RB)/114-39/2624 dated 26/11/2021 particularly denial for admission in B.H.M.S course by the affiliated University. Therefore, Commission reiterated the decision of MA&RB for denial of permission in BHMS course with intake capacity of 75 seats for the academic session 2021-22 vide Medical Assessment and Rating Board (MA&RB) letter No. 4-7/2021-22/NCH (MA&RB)/114-39/2624 dated 26/11/2021 due to denial of admission by the affiliated University. Accordingly representation dated 23.12.2021 to Commission against MA&RB was disposed off vide letter F. No. 3/47/2021/NCH/HEB/GR/ dated 03.02.2022.

6. WHEREAS, in view of the compliance of Hon'ble High Court order dated 22.03.2022 in W.P. No. 2925 of 2022, considering the consent of affiliation by MUHS, and availability of Guest faculties, Commission gathered that college has actually 07 eligible guest faculties available against the requirement of 12 for 75 seats. Therefore, it was not sufficient as per Schedule IV of MSR 2013 which is more than 10% deficiency of total requirement of eligible guest teachers. Therefore, in view of the same, Konkan Education & Medical Trust's Virar Homoeopathic Medical College, Veer Savarkar Marg, Virar, Tal.Vasai, Dist. Thane-401305, Maharashtra is allowed for admission to Ist BHMS course with intake capacity of 60 seats (reduced from 75 seats) for the academic session 2021-22.

7. The College shall comply with the provision for providing EPF and ESI facilities to the teaching, Non-teaching staff of the College/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

8. The College aggrieved by any decision of the Autonomous Board may prefer an appeal to the Ministry against such decision within 30 days of the communication of this order, as per Section 9(6) of NCH Act, 2020.
