Sir,

Konkan Education & Medical Trust Virar Homoeopathic Medical College, Veer Savarkar Marg, Virar, Tal.Vasai, Thane-401305 Maharashtra is functional since 1989 and has applied for permission for sanction of **UG (BHMS) course with 75 seats for the academic year 2024-2025**. The college has submitted the Part 1 information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under the NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls as per MSR requirements:

Teaching Faculties:

- 27 fulltime faculties are available against the requirement of 28.
- There is no Professor in the department of Practice of Medicine.
- 11 Guest Faculties are available against the requirement of 12.
- Affidavit is not available for Dr. Rohit Madhav Sane, Assistant Professor form the department of Anatomy.

Hospital Details:

- OPD/IPD Case records are not recorded properly. IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation and made available in Medical Record Room for academic purpose of students and follow up of patients.

Miscellaneous:

- College has not enabled the Adhaar Enabled Biometric Attendance system (AEBAS). This shall be enabled within a period of one month.

- Form-16 is not submitted from the traces portal. The same shall be send for verification.

Considering the above observations and facilities available, Medical assessment and Rating board has decided to issue **Conditional permission to Konkan Education & Medical Trust Virar Homoeopathic Medical College, Veer Savarkar Marg, Virar, Tal.Vasai, Thane-401305 Maharashtra for conducting UG (BHMS) course with 75 seats for the academic year 2024-2025.**


All deficiencies noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 75 UG shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective Counseling authority of State/UT Govt as designated by Central Government/NCH and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
